IMPORTANT NOTES

- Any person or partnership not exceeding two reserve the right to the use of any Prefix
 / Affix (Subject to Regulation 14 of Regulations for Registrations and such conditions as
 the Committee may prescribe) provided that no Prefix / Affix known to be registered
 abroad may be adopted in India except by registered owners thereof.
- 2. The declaration on reverse must be signed by BOTH persons in case of partnership.
- 3. A prefix / Affix shall not be transferable except with the prior sanction of the Committee.
- 4. A word registered as a Prefix / Affix may be used either as a Prefix or an Affix.
- 5. A registered Prefix / Affix must not be used as Part of the name of any dog which has not been registered with the Kennel Club of India.
- A registered Prefix / Affix can be used as part of the name only of a dog registered by the owner or such Prefix / Affix. It cannot be used for any dog bred by such owner and registered by any other person.
- 7. A breeder who desires to name pups with his registered Prefix / Affix must first register them in his own name and then transfer them to the new owners.
- 8. The Committee reserve the right to cancel any Prefix / Affix granted under an application. The owner may be allowed to reserve without further payment another approved Prefix / Affix and the name of any dog registered under the cancelled Prefix / Affix shall be changed and no fee shall be payable for such change of names.
- The committee reserve the right to refuse any Prefix / Affix without assigning any reasons therefor.
- 10. The granting of Prefix / Affix does not carry with the right to use the said Prefix/ Affix in connection with the name of any dog, already registered, unless application is made for changing the name (assuming it can be changed) and the prescribed fee is paid, vide Regulation 21 of Regulations for Registrations.
- 11. Notwithstanding paras 1 and 8 above, a breeder with a Prefix/ Affix duly registered with the K.C.I. who has requestioned the services of a stud dog whose owner has also a registered Prefix / Affix, may be the Prefix / Affix, of the owner of the sire in addition to his own in the names of note more than two puppies out of a litter sired by such dog, provided a written agreement to that effect, duly signed by the owners of both the dog and bitch is registered with the K.C.I. within eight days of the bitch being serviced.
- 12. Prefix / Affix is registered FOR LIFE ONLY ON PAYMENT OF Rs.10,000/-
- 13. Prefix / Affix will be registered as per FCI regulations as single word without space or special characters.
- 14. **I.K.G. subscription** is compulsory for Registering the Prefix / Affix.
